School District Chief to Speak at Club

Lieutenant Colonel William E. Harner, United States Army (retired) assumed his new role as superintendent of the Greenville County School District in July. During a distinguished 20-year military career he commanded a battalion at Fort Jackson, was chief of the policy and strategy office of U.S. forces in Korea, taught on leadership and character at West Point and served as aide de camp to the superintendent of the United States Military Academy.

Harner is a West Point graduate, and after a career serving in the US Army he received a masters in educational supervision from Troy State University. Mr Harner has served as principal of Hilton Head High School and this fall he will complete requirements for his doctorate in educational leadership and administration from the University of South Carolina.

Mr Harner has been described as a strong communicator and an enthusiastic leader. He will be leading the state's largest school district and the nation's 66th largest. He and his wife, Lindsley, have a 13-old son, Billy, and a 9-year old daughter, Jessica.
