Now in his second term of office, Mayor White continues his emphasis on advancing neighborhood initiatives, expanding development in the historic West End, promoting growth management through good planning, increasing residential and retail

development downtown, and the creation of a world-class public garden at Reedy River Falls.

He is a partner in the law firm of Haynsworth, Sinkler and Boyd, where he practices customs and immigration law.

A native of Greenville, Mayor White graduated from Christ Church Episcopal School, Greenville Senior High School, Wake Forest University, and the University of South Carolina School of Law.

Mayor White is married to Marsha White and they have two children — Marian, 15, and Knox Jr., 11.

He is a member of the North Greenville Rotary Club and Christ Church Episcopal. Mayor White is a member of the South Carolina Smart Growth Initiative State Coordinating Committee and serves as a board member for the South Carolina Children's Theatre and The Peace Center for the Performing Arts.
