

Vice Admiral Albert Konetzni Jr., Deputy and Chief of Staff for the U.S. Atlantic Fleet, will speak at the April 13 meeting of Greenville Rotary. Konetzni, born in New York City in 1944, attended the U.S. Naval Acad-

emy, where he graduated with merit and received his commission in 1966.

Following graduation from the Naval Academy, Konetzni attended Naval Submarine School in New London, Conn., Nuclear Power School in Mare Island, Calif., and Naval Nuclear Power Prototype Training in West Milton, N.Y.

Wells praises 'special' environment

T he business environment in the Greenville area "is special," Tom Wells, senior vice president of Rosen Associates Development Inc., told Greenville Rotarians at the March 23 meeting.

That "special" environment accounts for the Rosen company's eagerness to be part of the Clemson University ICAR project that is going on property once belonging to John D. Hollingsworth. Wells was the March 23 guest speaker because the company's president, Cliff Rosen, had a last-minute conflict.

The Rosen company is developing the Millennium Campus within the ICAR project. Its positioning statement is "Inspiring Innovation." It will develop more than 400 acres of the wooded, scenic land that is part of this public-private partnership.

The automobile industry is migrating to South Carolina for specific reasons, Wells said. Those include low taxes, availability of land, the pleasant climate, excellent labor force and high standard of living. Once BMW located in the Upstate, the suppliers wanted to move here, too, to be close to the manufacturer.

There also are more than 12 major colleges and universities within a 200-mile radius of Greenville, Wells said, and the South Carolina technical schools are great. One of the best tech schools is in our own backyard — Greenville Tech.

Preliminary economic numbers show that ICAR will bring \$2.6 billion in new investment and create 22,000 new jobs, Wells said. And he repeated Cliff Rosen's philosophy concerning public statements about a project's potential: "Underestimate and over-deliver."

We forget sometimes By Terry Weaver, President

T om Wells, our speaker on the International Center for Automotive Research (ICAR), reminded us of the many attributes and advantages of Greenville's location, our region's economic resources and the business climate we enjoy.

On a recent trip to South America, I was stunned by the contrast between their economies and ours. Imagine a business climate burdened by 80 different taxes, a five-month process to establish a company, double-digit inflation, impassable roads, limited available financing, and kidnappings for profit — all resulting in a population of which 50 percent are below the poverty line. This is life in the big economic "engines" of South America — Argentina and Brazil.

We sometimes forget the luxury of a business climate that supports business formation (which we can do in 48 hours versus five months), celebrates entrepreneurship, and has many available sources and means of raising capital.

ICAR is expected to be a catalyst for the formation of the hundreds of knowledge-based businesses that will be needed to support its mission. Its corporate sponsors — BMW, Michelin, IBM, Microsoft, et al — know that these entrepreneurships will be the sources of much of the innovation that they're expecting to spring from ICAR.

Brazil and Argentina have effectively shut down the small business segment of their economies through misguided, populist public policies. As Rotarians, let's regularly remind our elected officials to do the opposite.
