As we approach the holidays, it's a wonderful time for reflection on the many gifts we have been given, and to remember those in the world who may not be as fortunate. As Rotarians, we give boldly throughout the world through service, and our gifts through the Rotary Foundation.

Through our gifts to *The Rotary Foundation*, we help advance communities, improve health, and promote peace locally and throughout the world. Our gifts are essential to fund humanitarian projects, scholarships, and other activities. What's more, the money we raise for the Foundation benefits you, our district, and our club.



In this season, I hope you will strongly consider upping your commitment to the Foundation. In the next few days, you should receive a letter from me and Deborah Dunlap asking you to renew your commitment to the Foundation. Please take advantage of the match we are providing to move you to the next Paul Harris Fellow level.

A refresher in the opportunities for giving is appropriate. Below are some of the ways you can give to Rotary.

- **Rotary Foundation Sustaining Member**, when you give \$100 or more per year to the Annual Fund. This is included on invoices mailed in June. Most of us have given to this already.
- **Paul Harris Fellow**, when you cumulatively give \$1,000 or more to the Annual Fund, PolioPlus, or an approved Foundation grant. You are recognized as a Multiple Paul Harris Fellow with each additional gift of \$1,000. To recognize someone else as a Paul Harris Fellow, you can give that amount in their name. Rotary points may be used to achieve this level, and the club will match your gift through January 31.
- **Paul Harris Society** member, when you give \$1,000 or more annually to the Annual Fund, PolioPlus, or an approved Foundation grant.
- **Benefactor**, when you include the Endowment Fund as a beneficiary in your estate plans or when you donate \$1,000 or more to the fund outright. Benefactors receive a certificate and insignia to wear with a Rotary or Paul Harris Fellow pin.
- **Bequest Society** member, when you give \$10,000 or more via your estate plans. All society members receive recognition from the Trustees of The Rotary Foundation, and donors can choose to receive an engraved crystal recognition piece and a Bequest Society pin.
- **Major Donor**, when your cumulative cash donations reach \$10,000. You can choose to receive a crystal recognition piece and a Major Donor lapel pin or pendant. Club or individual Rotary points may not be used to reach this level. Additionally, major donor status may be achieved this year with a pledge to pay up to \$10,000 payable over the next three years.

I hope you will give joyfully this year, and I look forward to seeing you out at the mountain at Holiday Lights.





The signing will be on the mountain at Winter Wonderland on Thursday, December 11, Friday, December 19, and Saturday, December 20 from 6:00 to 9:00 p.m. The book will be sold for \$8.00 at Winter Wonderland.

Roper the Ogre lived on a mountain in Greenville a long time ago. No matter how hard he tries to be friendly, everyone is scared of him. To spite the people of Greenville, Roper decides to steal all the candles that make everyone else so happy during the holidays. The mayor, the city council, and especially all of the children are sad, until one of the children has an idea. Each will choose a gift to give to Roper, and maybe the ogre will give their lights back! This rhyming story gives an imaginative account of the inspiration for Roper Mountain Holiday Lights, a Greenville, South Carolina holiday tradition.

Net proceeds from the sale of this book will go to Holiday Lights, Inc. for the benefit of the Roper Mountain Science Center and multiple community service projects of the Rotary Club of Greenville.

About the author:

Dr. Frederick (Fred) Baus has a 45-year career in the administration of non-profit, higher education associations, including serving as president of the University Center of Greenville. Fred and his wife, Cathy, live in Simpsonville, SC. After his retirement in 2013, Fred began writing poetry for children. In December 2013, while waiting in line on a trip to Roper Mountain Holiday Lights with his wife and grandsons, one of the boys asked, "So where are the lights?" The muses struck, and Oh. Those Holiday Lights! is the result. In talking about the book, Baus notes, "The themes of caring and sharing reflect the spirit of Greenville, the underlying message of the Holiday Lights project, and a lesson we could all do well to remember throughout the year."
