Governor Henry McMaster

Henry Dargan McMaster of Columbia became the 117th Governor of South Carolina on January 24, 2017. The son of attorney and former state representative John Gregg McMaster and Ida Dargan McMaster, Governor McMaster is a lifelong servant of the State of South Carolina, having previously served two years as lieutenant governor, eight years as attorney general and four years as United States attorney.

McMaster was the first U.S. attorney appointed by President Ronald Reagan, and was unanimously confirmed by the United States Senate. His "Operation Jackpot" investigation into international drug smuggling produced over 100 convictions.

As attorney general, McMaster made prosecution of criminal domestic violence a priority and harnessed the resources of law enforcement and prosecutors to crack down on child Internet predators. He extended the state grand jury's jurisdiction to environmental and gang crimes and broadened its authority to include securities crimes following the collapse of Carolina Investors and Home Gold, convicting those responsible.

In 2012, McMaster and former attorney general Travis Medlock led a bipartisan commission to reform ethics laws and restore the public's trust in state government. McMaster was chairman of the South Carolina Republican Party from 1993-2002, winning reelection three times. As state GOP chairman, he led the party to Republican majorities in South Carolina's House and Senate.

Governor McMaster has served on the South Carolina Ports Authority Board of Directors, the South Carolina Commission on Higher Education, the Palmetto Health Foundation Board and the South Carolina Policy Council (as chairman). He is admitted to practice in all courts, state and federal, in South Carolina, as well as the U.S. Court of Claims (1974), the U.S. Court of Appeals for the Fourth Circuit (1975) and the Supreme Court of the United States (1978). Governor McMaster is a recipient of the Order of the Palmetto, the highest civilian honor in the state, and was named "Public Servant of the Year" by the Sierra Club and "National Law Enforcement Officer of the Year" by The Humane Society of the United States.

McMaster received his AB degree in history in 1969 from the University of South Carolina and his JD degree in 1973 from the University of South Carolina School of Law, where he served on the South Carolina Law Review. He served in the U.S. Army Reserves in the JAG Corps from 1969 to 1975.

Governor McMaster is married to Peggy McMaster, and they have two children, Henry D. McMaster, Jr. and Mary Rogers McMaster. They are members of First Presbyterian Church of Columbia.

Remembering Virginia Uldrick

Virginia Uldrick, a towering and beloved figure in education and the arts in Greenville, has passed away.

Uldrick, a deep-voiced opera singer and choral director, founded the South Carolina Governor's School for the Arts and Humanities and the Greenville school district's Fine Arts Center.

She's also fondly remembered for creating and leading Greenville's "Singing Christmas Tree," which featured high school choristers singing in a huge Christmas tree-like structure.

"Her greatest contribution was her love of teaching and mentoring young artists as if she was sent from above to inspire generations of young people," said Ann Hicks, the former arts writer for The Greenville News.

Uldrick's career as a music teacher and educational leader spanned more than 50 years in Greenville County before her retirement in 2003.

Uldrick started the "Singing Christmas Tree" in the 1960s, the Fine Arts Center in 1974, the six-week summer Governor's School in 1981 and, at age 70, the residential Governor's School in 1999.

She became the first president of the residential Governor's School after steadfastly advocating for the concept for 14 years. Earlier, she had led the Fine Arts Center, a magnet program, and taught music at Greenville High School.

Working with elected officials and community leaders to create the Fine Arts Center and later the Governor's School from scratch, Uldrick was a formidable force.

"She was determined and so committed to helping young people improve their education through the arts," said Dick Riley, the former U.S. Secretary of Education and South Carolina Governor. "She influenced South Carolina and especially Greenville in a very big way. Everything she touched was beautiful and worthwhile. She was a wonderful person."

Uldrick in 2014 was honored with Greenville's first statue of a woman: a representation of Uldrick conducting music students. The statue stands at the front of the Governor's School.

She was one of the first two women (along with Jeanet Dreskin) to join the Rotary Club of Greenville when Rotary opened its ranks to women in 1988.


